3. Prof. Sandeep Kumar, Department of Geology



“University’s decision to constitute a committee to look into the conduct rules Of the Teaching/University Employees whether the same permit the University Teachers/Employees to file RTIs pertaining to the functioning of various offices of the University”

After threadbare deliberations on this issue, EC unanimously resolved that this move of the University is in violation to RTI Act itself and every member present at the meeting expressed that such moves at the Institution of highest learning are quite surprising and are not good for improvement and smooth functioning of the Institution.
